New York General Assembly 2006 Registration Form

IHEU's General Assembly is the policy making and controlling body of IHEU and the General Assembly meeting is a business meeting. It is made up of members of the Executive Committee, representatives of IHEU's Member Organizations, Sections & Committees, and IHEU's International Representatives. The agenda for the New York GA 2006 will include Annual Report, Financial Statements, and Elections to the IHEU's Executive Committee. The General Assembly shall be chaired by an Executive Committee member or a voting member elected by the General Assembly.

IHEU Individual Supporters who have notified the IHEU within the stipulated dates through the appropriate registration form may also attend. GA documentation will then also be sent to them. Invitees to the GA may include representatives of organizations applying for IHEU membership, who along with the Individual Supporters will attend as observers. Individual Supporters, invitees and observers may speak only with permission from the Chair.

Member Organizations have to be fully paid up with regards to their IHEU dues in order to exercise their vote.

The attached Registration Form is for both representatives of IHEU Member Organizations and for Individual Supporters and invitees and consists of two parts: Registration; and Agenda item/Resolution proposal to the GA.

Member Organizations wishing to make proposals for agenda items and resolutions for the GA will need to send this form to IHEU headquarters to arrive by **Friday 17 February 2006**.

The GA registration form must be returned at the very latest to the IHEU Headquarters office in London to arrive by **Monday 20 March 2006** (30 days before the date of GA).
